The College of Animal Welfare's Advanced Learner Loans Bursary Fund is provisioned by government funding in order to try to assist vulnerable learners who have applied for an Advanced Learner Loan, such as those with learning difficulties or disabilities, parents who need help with childcare, and ex-military personnel so they are able to commence, continue or complete their studies. Other disadvantaged learners will also be considered.

Applicants must have enrolled with the College and had their Advanced Learner Loan agreed by the Student Loans Company (SLC). Any payments awarded will only be made once the learner has commenced their course. The available support fund is not vast and applications will be considered on an individual basis. Grants up to a maximum of £250 will be considered unless in exceptional circumstances.
