This evidence will then be used to support problem solving and aid decision making.

You will be able to take these skills forward to support your future studies, particularly to the level 6 QI project, and professional careers.

Applied Emergency and Critical Care for Veterinary Nursing

Module Aim

This module will provide you with knowledge and skills to enable you to deliver safe and effective veterinary nursing care to a range of species with a range of emergency and critical care disorders.

You will utilise evidence-based veterinary nursing care, veterinary nursing models and frameworks to recognise, assess and successfully manage emergency and critically ill veterinary patients.

Learning Outcomes

- Critically explore the role of the veterinary nurse in the provision of first aid and triage in relation to professional legislation and guidelines.
- Critically evaluate patient monitoring methods and equipment used for a variety of emergency and critical care situations.
- Critically evaluate current literature to examine veterinary nursing techniques for a range of emergency and critical care patients.
- Create nursing care plans for critical care patients and justify their value in an emergency or critical care context.

Anaesthesia for Veterinary Nursing Practice

Module Aim

This module will enable you to critically evaluate the veterinary nursing care provided to patients undergoing anaesthesia. You will develop your current professional anaesthesia veterinary nursing skills by exploring and evaluating the veterinary nursing needs of individual patients undergoing anaesthesia in order to plan and deliver appropriate veterinary nursing care. You will consider how patient preparation, patient factors, anaesthetic equipment and monitoring impacts on veterinary patient care. The current evidence base will underpin learning.

Learning Outcomes

- Critically evaluate perioperative patient requirements, relating to principles of anaesthesia in companion animals.
- Evaluate and plan the safe use of anaesthetic and patient monitoring equipment.
- Critically explore and justify the role of the veterinary nurse in supporting patients undergoing anaesthesia.


