**Post Title:** Veterinary Nursing Lecturer

**Hours of Attendance:** Normally 37.5 hours per week. The appointee will be expected

to work flexibly to meet the requirements of the post.

#### **Detailed Tasks**

## 1. <u>Lecturing across a range of courses including short courses</u>

- 1.1 Deliver an appropriate learning programme in accordance with the Awarding Body guidance & Individual Learning Plan, embedding basic skills and functional skills support.
- 1.2 Lecture across a range of subjects using a variety of teaching and learning strategies demonstrating consideration of individual learner needs, interests, skills and aptitudes to enable achievement of their learning goals.
  - 1.3 Promote inclusive learning and group participation to encourage learner involvement in the negotiation of learning outcomes.
- 1.4 Ensure that all learners learn in a safe environment free from oppression and discrimination.
- 1.5 Develop and prepare a variety of learning resources relevant to the programme and the learner's needs.
- 1.6 Upload all appropriate learning materials to the VLE prior to lectures to provide adequate preparation time for all learners.



- 1.7 Conduct initial and on-going assessment (formative and summative, including marking of initial/final assignments) so that learners are aware of and involved in assessing their progress and the achievement of their learning goals and so that an individual learning plan can be developed.
- 1.8 Provide regular detailed feedback to learners and their employers regarding progression and achievement.
- 1.9 Develop strategies with learners to improve retention, achievement and agree targets with the manager.
- 1.10 Provide support and guidance to promote timely completion of NPL in the capacity of Personal Tutor.
- 1.11 Monitor learner attendance/punctuality and classroom behaviour, and act in accordance with Academic Quality Handbook when necessary.
- 1.12 Completion of academic registers.
- 1.13 Completion of syllabus tracking to demonstrate full coverage of curriculum.
- 1.14 Undertake the administrative duties required to evidence teaching and learning as outlined in the Academic Quality Handbook.
- 1.15 Conduct learner reviews in line with funding contract expectations to monitor progression, provide support & guidance. Report unusual findings or concerns to the Head of Veterinary Studies and others as appropriate.
- 1.16 Implement evaluations and review of provision in accordance with Academic Quality Handbook.
- 1.17 Attend team meetings (every 4 6 weeks) to discuss learner progression.
- 1.18 Attend Academic Meetings at request of line manager.
- 1.19 Attendance at Student Awards Ceremony at the request of line manager.
- 1.20 Attend relevant meetings and events at other CAW centres as required.

## Student/Trainee Safety/H&S at Work

- 2.1 To comply with the Health & Safety at Work Act.
- 2.2 To comply with The College of Animal Welfare Health & Safety Regulations.
- 2.3 To ensure that student safety is considered at all times.
- 2.4 To participate in maintaining awareness of Health & Safety at the College and in the workplace.
- 2.5 Draw to the attention of the line manager any issues of Health & Safety and to comply with the Health & Safety procedures required.

#### 3. <u>Student Recruitment/Careers Events/Liaison</u>

- 3.1 To promote all courses and assessment opportunities to employers and learners.
- 3.2 To participate in the marketing of all course provision at career conventions, open days, exhibitions and veterinary conferences.
- 3.3 To maintain and enhance existing links with the College of Animal Welfare.
- 3.4 To foster and develop collaborative links with other relative associations.
- 3.5 To foster and develop links with employers and other stakeholders.

## 4. <u>Information, Advice & Guidance</u>

- 4.1 Provide all learners and potential learners with accurate and up to date information and advice that enables them to make informed choices about lifelong learning and work.
- 4.2 Be impartial and signpost people to the most relevant and appropriate source of information, advice or guidance.
- 4.3 Actively promote high quality information, advice and guidance.
- 4.4 Listen to what clients of our service say about our provision and continually improve our delivery.

## 5. Safeguarding

- 5.1 Ensure you know the name of the designated person and their role.
- 5.2 Know how to pass on and record concerns about a child or young person.
- 5.3 Understand individual responsibility for referring child protection concerns using the proper channels and within the agreed timescales.
- 5.4 Attend Induction training for Child Protection and attend a refresher on a three yearly basis so that you know your responsibilities, the local procedures, the need to be vigilant in identifying cases of abuse and how to provide support and respond to a student who tells of abuse.
- 5.5 Ensure concerns about poor or unsafe practice in regard to students are raised in a timely manner.
- 5.6 Be clear with students that you cannot promise to keep secrets.
- 5.7 Ensure that the five Every Child Matters outcomes being healthy, staying safe, enjoying and achieving, making a positive contribution and achieving economic wellbeing are met.
- 5.8 Promote health in areas such as:
  - Smoking
  - Drug and alcohol use
  - Disease prevention and control
- 5.9 Review policy and procedures on an annual basis.
